

## HSK SILVER SATURDAY RAFFLE OFFICIAL RULES

**NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.**

**Eligibility.** The HSK Silver Saturday Raffle (the “Raffle”) is open only to legal residents of the state of Nevada who are at least 18 years of age at the time of entry (the “Entrant”). The Raffle is void elsewhere and where prohibited by law.

Provided an Entrant’s Submission conforms to these Official Rules, upon completing a Submission, each Entrant will receive one (1) entry into the Raffle. **Limit one (1) entry per person and per email address during the Raffle Period.**

No other methods of entry are acceptable. Submissions will not be returned or acknowledged. Entrants agree that the rights granted to Sponsor in these Official Rules are without compensation or attribution of any kind. By entering this Raffle, Entrants agree to be bound by these Official Rules, including all entry requirements.

Persons who tamper with or abuse any aspect of the Raffle, act in violation of the Official Rules, or act in any manner to threaten or abuse or harass any person, or violate any website's terms of service, as solely determined by Sponsor, will be disqualified. Any use of robotic, macro, automatic, programmed or like entry methods will void all such entries, and may subject that Entrant to disqualification. Released Parties are not responsible for injury or damage to Entrants' or any other person's computer or property related to or resulting from participating in this Raffle. Should any portion of the Raffle be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in sole opinion of the Sponsor, corrupt or impair administration, security, fairness or proper play of this Raffle, or submission of entries, the Sponsor reserves the right, in their sole discretion, to suspend, modify, or terminate the Raffle, and randomly select the potential winners from valid entries received prior to the action taken, or otherwise as may be deemed fair and equitable by the Sponsor.
