

## **HSK - TOYOTA SAFE DRIVER SWEEPSTAKES OFFICIAL RULES**

**NO PURCHASE NECESSARY. A purchase will not increase your chance of winning.**

**Eligibility.** The HSK Toyota Safe Driver Sweepstakes (the “Sweepstakes”) is open only to legal residents of the state of Nevada who are either (i) 18-20 years of age at the time of entry or (ii) 16-17 years of age at the time of entry with consent of parent/guardian (in either case, an “Entrant”). The Sweepstakes is void elsewhere and where prohibited by law.

Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of (i) Sponsor (defined below), (ii) Black Knight Sports and Entertainment LLC, (iii) National Hockey League and National Hockey League teams (collectively, the “NHL Entities”), (iv) American Hockey League (“AHL”), other AHL teams, Indoor Football League (“IFL”), other IFL teams (collectively, the “AHL/IFL Entities”), (v) Toyota Motor Sales, U.S.A. **Sponsor.** Foley Entertainment Group, LLC, 1550 S. Pavilion Center Drive, Las Vegas, Nevada 89135 (“Sponsor”). For avoidance of doubt, no Toyota Entity is a sponsor of the Sweepstakes.

**Agreement to Official Rules.** By entering this Sweepstakes, Entrants fully and unconditionally agree to and accept these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes.

**Timing.** Sweepstakes begins at 6 am Pacific Time (“PT”) on Monday December 29, 2025 and all entries must be received by 10:00 pm PT on Friday January 16, 2026 (the “Sweepstakes Period”). Sponsor’s servers and clock shall serve as the official clock for the Sweepstakes and Entrants’ proof of submission does not constitute proof of receipt by Sponsor.

Entrants will be required to submit certain personal information including, but not limited to, the Entrant’s name, email address, phone number, date of birth, and name of Entrant’s parent/guardian (if the Entrant is considered a minor in his/her state of residence). Sweepstakes entry materials shall hereinafter be referred to as “Submissions”.

Provided an Entrant’s Submission conforms to these Official Rules, upon completing a Submission, each Entrant will receive one (1) entry into the Sweepstakes. **Limit one (1) entry per person and per email address during the Sweepstakes Period.**

No other methods of entry are acceptable. Submissions will not be returned or acknowledged. In the event of a dispute regarding the identity of the person who submitted an entry, the entry will be deemed submitted by the Authorized Account Holder (defined below) of the e-mail address included with the entry. “Authorized Account Holder” is defined as the natural person who is assigned to an e-mail address by the Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Each Entrant further agrees and warrants that his/her Submission shall not: (a) be false, inaccurate, or misleading; (b) infringe or otherwise violate any third party's copyright, patent, trademark, trade secret, or other proprietary rights or rights of publicity or privacy; or (c) violate any law, statute, ordinance, or regulation; in each case as determined by Sponsor, in its sole discretion. Sponsor reserves the right to disqualify an entry with offensive content or material that it feels is inappropriate in any way. Late entries or entries sent via any other method than those stated above will not be accepted.

**Prize/Value/Odds.** One (1) prize will be awarded:

- One (1) Henderson Silver Knights jersey. Approximate Retail Value ("ARV"): \$130
- Two (2) Tickets to the Henderson Silver Knights home game on 1/25/2026. Approximate Retail Value ("ARV"): \$40

Odds of winning will depend on the total number of eligible entries received.

**Prize Conditions.**

**All ticket elements of the prize must be used on the game date as described above or winner forfeits prize.** All other expenses and incidental costs not expressly stated in the prize descriptions above, including but not limited to, ground transportation, meals, incidentals, parking, gratuities, taxes or other expenses are the responsibility solely of the winner (and if considered a minor in the state in which he/she resides his/her parent and/or legal guardian). Entrants agree that the rights granted to Sponsor in these Official Rules are without compensation or attribution of any kind. By entering this Sweepstakes, Entrants agree to be bound by these Official Rules, including all entry requirements.

Persons who tamper with or abuse any aspect of the Sweepstakes, act in violation of the Official Rules, or act in any manner to threaten or abuse or harass any person, or violate any website's terms of service, as solely determined by Sponsor, will be disqualified.
